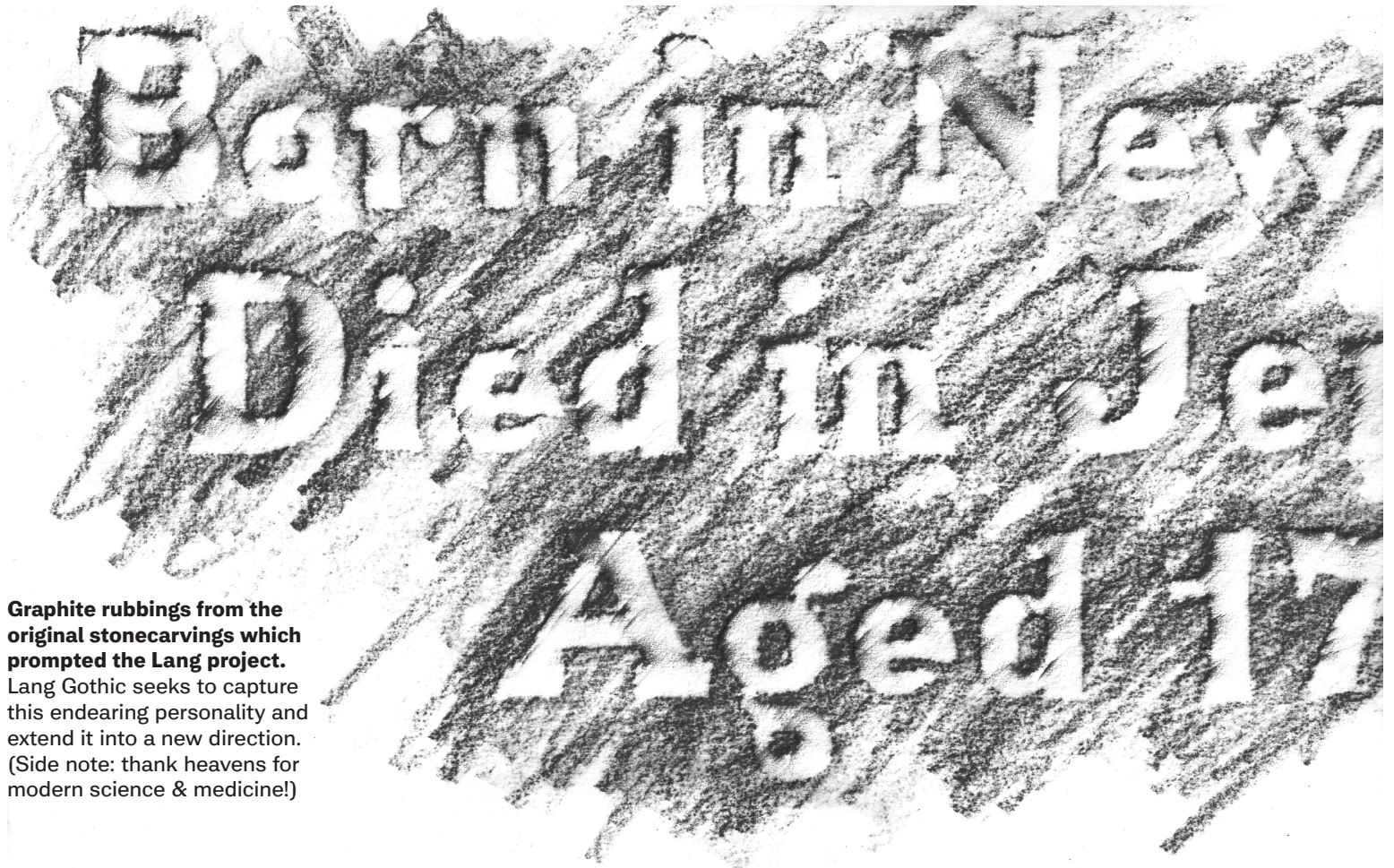
AT Lang Gothic

LANG GOTHIC

is a multipurpose sans-serif typeface made in the gothic genre – historical American sans-serifs that have personality but don't draw too much attention to themselves.

It is made as a companion to **AT Lang**, which is a type family derived from a surprisingly friendly, semi-slab style of lettering in 19th-century grave carving found within the Green-Wood Cemetery of Brooklyn, New York.

Lang Gothic excels at medium to small sizes, but it has enough presence and sturdiness to hold its own when used at larger sizes.

AT Lang excels at medium to large sizes, but has enough spacing and sturdiness to read comfortably when used at smaller sizes.

AT Lang is an exploration of a “semi-slab” style of design, where there are some serifs, but not in all of the usual serif places.

AT Lang & AT Lang Gothic share many font traits like *line heights, character heights, and overall color*, making them easy to use together.

As a family intended for both text and display purposes, AT Lang includes weights from Thin (100) to Black (900), plus Italics.

AT Lang Gothic excels at medium to small sizes, but still has enough personality and craft to shine when used at larger sizes.

AT Lang Gothic is an exploration of how the core shapes and aesthetics of Lang can be translated into a sans-serif, with old and new ideas.

AT Lang Gothic & AT Lang share many font traits like *line heights, character heights, and overall color*, making them easy to use together.

As a family intended primarily for text purposes, AT Lang Gothic has a planned weight range of Light (300) to ExtraBold (800), plus Italics.

Weights & Italics

Lang Gothic is intended for small to medium usage, especially from about 12 points to 48 points. However, it also has enough personality to shine at large sizes.

The v0.4 release includes 12 styles – plenty of range for a dialing in graphics, without too many styles to get lost in.
