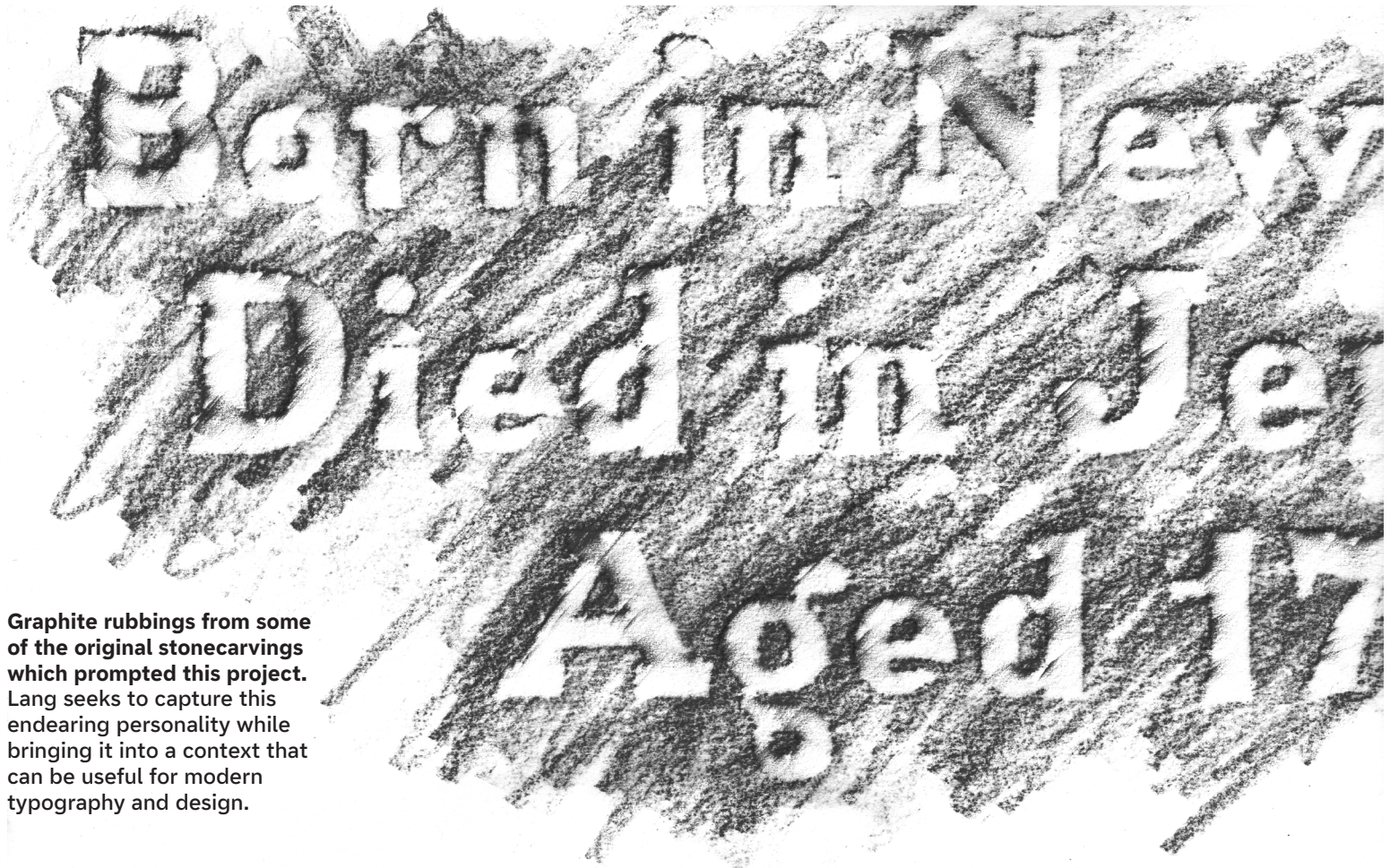

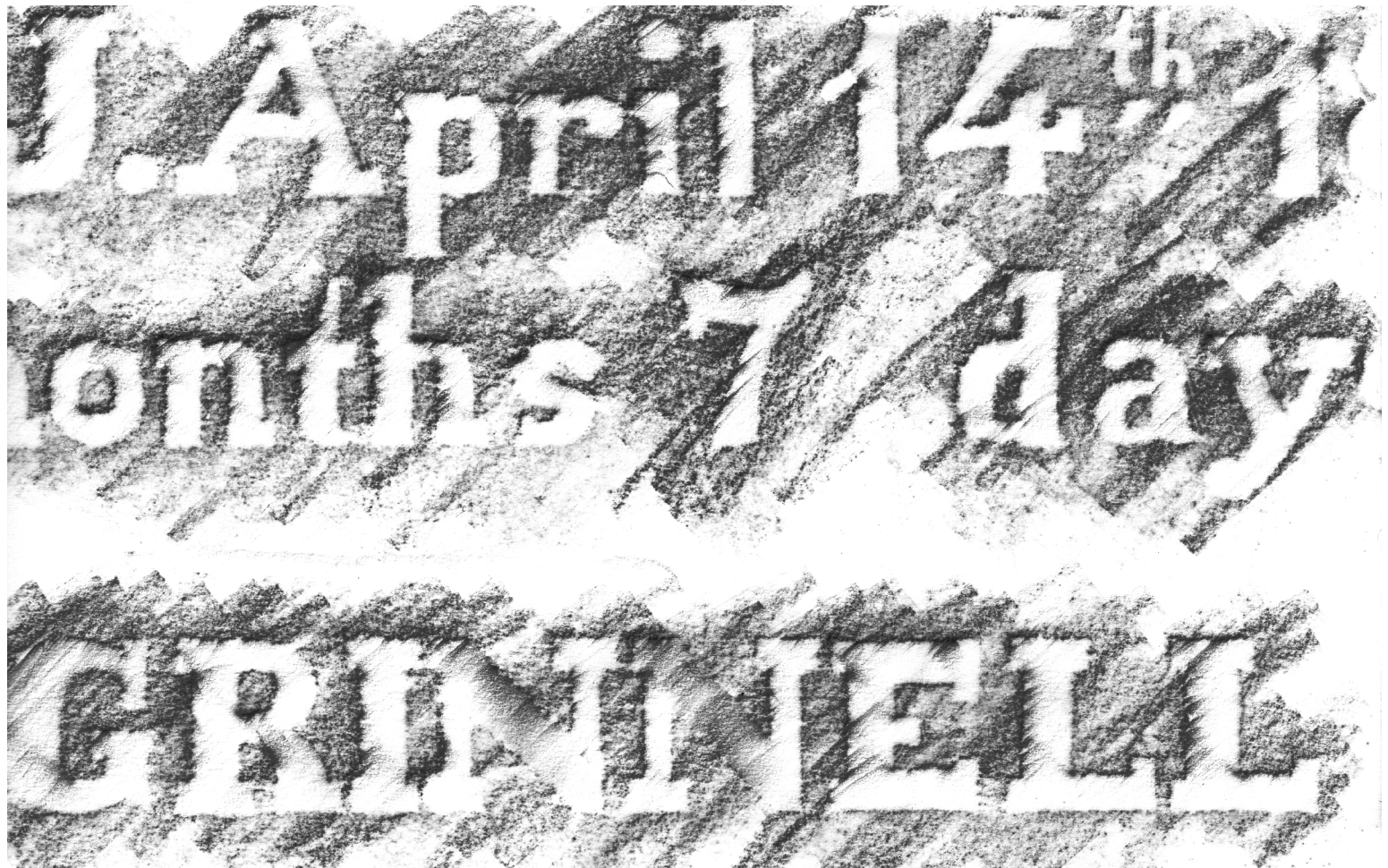
is a type family derived from a recurrent (surprisingly friendly) semi-slab serif style of lettering in 19th-century grave carvings within the Green-Wood Cemetery of Brooklyn, New York.

Lang is an exploration of dualities: life & death, past & present, self & family, nature & design, tradition & progress.





Graphite rubbings from some of the original stonecarvings which prompted this project. Lang seeks to capture this endearing personality while bringing it into a context that can be useful for modern typography and design.





Design Attributes, Roman

Lang might at first appear to be a familiar slab-serif typeface, but it brings a few new moves to the table.

The uppercase takes on slab-serif forms, adding in a few of its own gestures. Meanwhile, the lowercase is a little bit more peculiar, offering semi-slab, partly-italic forms.

The end result is a family that defies expectations, offering an aesthetic that manages to be sturdy yet delicate and serious yet playful.

The root of Lang’s uppercase is a sturdy, no-nonsense slab serif form, with timeless forms that feel solid.

A few characters do add in a little bit of nonsense, like the **R** with its ultra-confident leg. Pure sprezzatura!

The contrast has a few surprises. Vertical serifs are rarely the same thickness as thin strokes. Here, they are!

The lowercase is a semi-slab design, excluding serifs that would typically appear in a roman design, and instead opting for serif placement more typical of italics. This simplification yields a slightly playful, lighter tone to what might otherwise be an overly serious and heavy design.

In contrast to their curvy exteriors, many letters have straight-sided interiors. Curves are more difficult to carve than lines, so perhaps the original letter carvers deployed square counters for efficiency.

“A typeface is a beautiful collection of letters, not a collection of beautiful letters.” Why not both? Some forms are too fun to cut out, even if they stand out a little. (There is also a “normal g” in ss03, though.)

The roman includes various semi-italic details, such as the rounded terminals on the lowercase **s**, which would more typically be rectangular in a normal slab-serif typeface.

## Design Attributes, Italic

Lang Italic complements its upright counterpart with a set of heavily slanted and truly italic forms, delivering a nearly cursive appearance.

In text and complex typography, this provides a not-subtle emphasis. On its own, Lang Italic takes on a tone that is striking yet occasionally solemn.

For the most part, the italic uppercase is similar to its roman counterpart, with glyphs sloped & corrected.

A few characters do add in a little bit of italic flair, like the **R** with another nice leg. Pretty predictable!

Thinner weights maintain the monolinear contrast of thin strokes and serifs, resulting in a delicate & unique aesthetic.

If Lang (roman) is partly italic, then Lang Italic is extra italic, with a near-cursive appearance. This isn't simply done for purposes of visual contrast, but is also another reference to a common, beautiful lettering style in Green-Wood Cemetery.

Slanted letters are seldom simply slanted in a quality italic font. Making curves look "right" after adding a slant is a process of experimentation and iteration, requiring a manual correction of each and every curve.

As in most italic serif fonts, the **g** takes a fairly simple, single-story form.

The roman **s** is already mostly italic, so the italic **s** is simply slanted and corrected.

Styles

Lang is primarily intended for large usage, especially at about 40 points and above. But, add a bit of tracking, and it'll work pretty well at smaller scales, too.

The v0.4 release includes the full designspace, including 18 styles offered as individual static fonts, along with two variable fonts (Roman & Italic) which both include the full weight range in a continuous spectrum.

## Small Capitals

Small capitals are offered via the **smcp** and **c2sc** OpenType features of Lang. This can refine the typography of acronyms like NASA, and it simply provides additional typographic range.

Small caps are designed to match the weight and design of the family – they aren't simply the uppercase scaled down. This system supports the full character set, with small capitals available for all

accented characters in the family. Small cap numerals and punctuation can also be activating through the "All Small Capitals" (**c2sc**) OpenType feature.

**Swash Capitals  
(Italics Only)**

Swash capitals are offered via a *swsh* OpenType feature in the Italic styles of Lang. This intelligently assigns specific swash forms to letters at the beginning, middle, and end of each word.

This system supports the full character set, with swash capitals available for all accented characters in the family. Get fancy in (almost) any Latin-script language!

For extra legibility in swash capitals, you can also activate Stylistic Set 4, which returns I, J, and T to their more typical Roman forms.

## Contextual Alternates and Ligatures

Some letter combinations can cause visual problems where their default shapes might "crash" in some weights. In Lang, Contextual Alternates (calt) will automatically swap-in modified glyphs to handle this.

Some of these letter combinations can also be solved with Ligatures (liga) that swap in single glyphs which include two or three characters.

By default, Lang employs both **calt** and **liga** features to offer the most visually-refined, stylish text. In some circumstances, you may wish to turn off ligatures (e.g. for added legibility). In such cases, you should still leave ON contextual alternates.
